Please note: If you have your plates made outside the 90 calendar days, you will need to pay the appropriate fees. Fees range from \$20.95 to \$74.95 depending on the plate style.

Plates can be couriered for an additional charge of \$9.20 city or \$12.70 rural.

Things you will need to know when you request your plate

FIRST TIME MANUFACTURE OF PLATES - For the first time issue of plates.

The following criteria must be met before the order to manufacture a new set of Personalised Plates can be accepted:

- The applicant must be the person registered in respect of the vehicle, or the person who will be registered in respect of the vehicle if the vehicle is not yet registered in New Zealand. If the applicant wishes the plates to go on a vehicle that is not registered in their name then they must complete a transfer of entitlement to the registered person.
- The vehicle must be currently registered and licensed, or about to be registered.
- The applicant must provide the plate number of the vehicle that the Personalised Plate will be attached to. If the vehicle is not yet registered in New Zealand, then they must provide the VIN/Chassis number of the vehicle, and include documentation with this application to prove that they have recently purchased the vehicle (for example, sales and purchase agreement, import order). When the vehicle is ready to be registered, you must take the personalised plates into a plate agent and complete the relevant transactions (eg *Application to register motor vehicle MR2A*), before they can be attached to a vehicle.

PRIVACY STATEMENT: The particulars specified on the *Application for personalised plate manufacture* form will be stored and used by LicenSys to ensure correct manufacture of personalised plates, and to comply with the audit requirements of the NZ Transport Agency. The information will also be passed to the Transport Agency and stored and/or form part of the Motor Vehicle Register. Collection and dissemination of this information is authorised by Part 17 of the Land Transport Act 1998. Corresponding information held on other parts of the register may be amended.

Under the Electoral Act 1993, s 263B, the Transport Agency is authorised to release information for data matching purposes to the Electoral Enrolment Centre.

The Privacy Act 1993 provides rights of access to, and correction of, any readily retrievable personal information held about you by LicenSys or the Transport Agency.
